Consultation and Consent

- All clients must attend a mandatory consultation form and consultation before treatment
- A consent form must be signed confirming understanding of risks, benefits, results, and aftercare.
- Clients must inform us of any changes in health status prior to future appointments.

Treatment Expectations

- HIFU fat reduction results vary depending on individual factors such as lifestyle, metabolism, and adherence to aftercare.
- A course of treatments may be required to achieve desired results.
- No guarantees are made regarding the outcome.
- Photos may be taken before and after treatment for clinical comparison and may be used (anonymously) for marketing purposes, with client consent.

Contraindications

HIFU fat reduction is not suitable for clients who:

- Are pregnant or breastfeeding.
- Have metal stents/implants, permanent dermal implants, electrical devices (medical or none), implants such as pacemakers near the treatment site
- Have an active skin infection, severe acne in the treatment area, open wounds, lesions, skin irregularities or keloid scars
- Active systematic or skin disease which may hinder regeneration
- Hemorrhagic disorders or dysfunctions
- Blood clotting disorders
- Anti-thrombosis therapy
- Have uncontrolled diabetes, cancer, liver/kidney disease, or are undergoing radiation therapy.
- Are currently undergoing cancer treatment
- History of cancer
- Have a history of epilepsy, uncontrolled thyroid disorders, or autoimmune conditions
- Heart disease
- Any current general illnesses or disease
- Trauma or inflammation on the treatment area
- Suffer from migraines
- Feeling numb or no response to cold and/or heat
- Within 2 weeks before and after botox

Clients must inform us of any diagnosed health conditions prior to treatment.

Cancellations and Refunds

- Appointments must be rescheduled at least 72 hours in advance.
